Dear Foretravel Owner:

This notice is sent to you in accordance with the **National Traffic and Motor Vehicle Safety act**.

Foretravel Motorcoach has decided that certain 2024 through 2027 model year, Foretravel Realm FS605P and Realm vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 108, "Lamps, Reflective Devices, and Associated Equipment."

Please Note: Foretravel Motorcoach has 51 vehicles involved with this recall. This notice applies to the vehicle identification number below;

4VZ1U1R13SC09235

What is the defect?

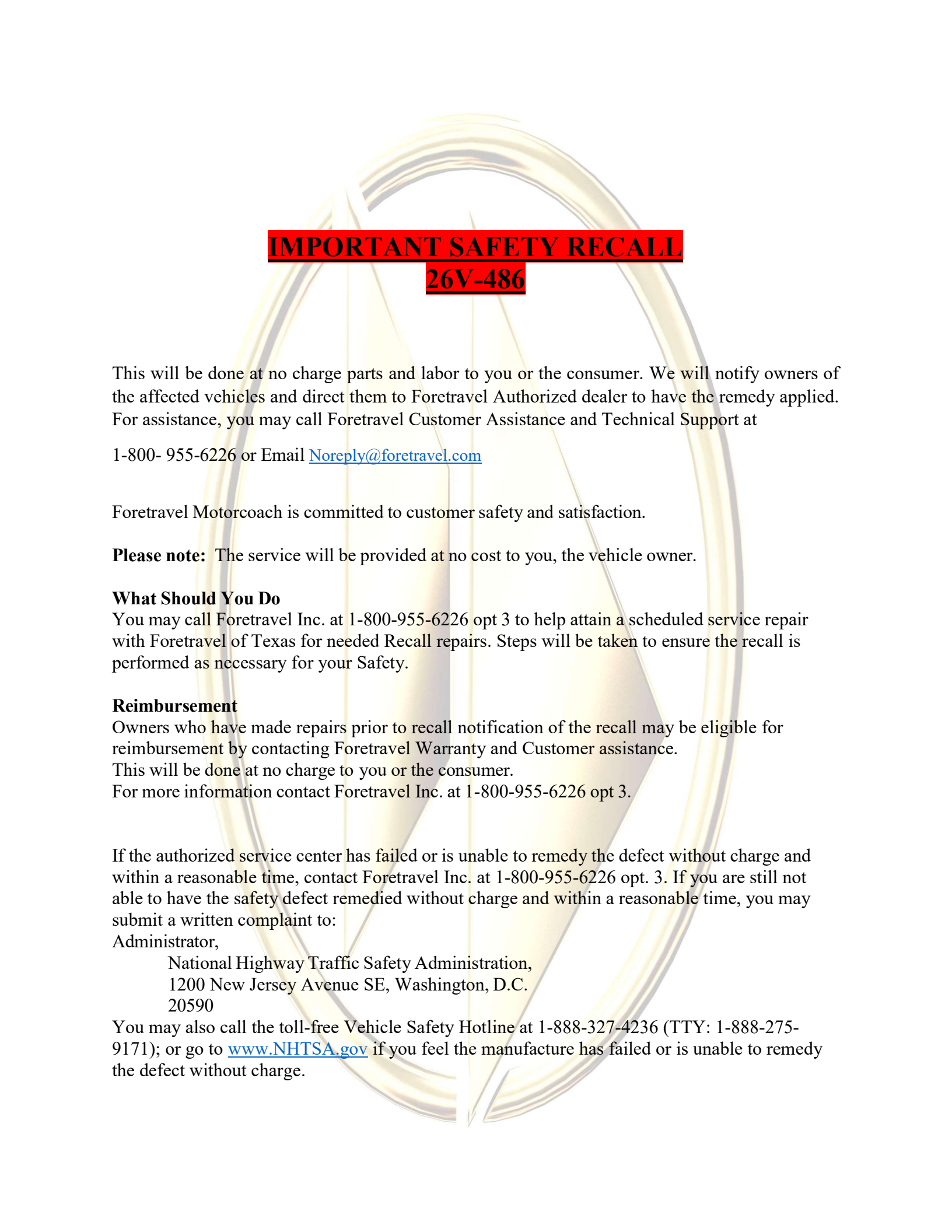
The affected chassis fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 108 – Lamps, Reflective Devices, and Associated Equipment. The brake pressure switch used in the air brake system may retain enough residual air pressure causing the brake lamps to be illuminated when the service brakes are not applied. Brake lights that remain on may fail to alert other vehicles of the driver's intention, increasing the risk of a crash.

Corrective Action

Foretravel will work with Shyft to install a new pressure switches with a pressure setting that will cause the brake lamps to not be illuminated with residual air pressure. The repair is expected to up to 1 hour and will be performed at no charge.

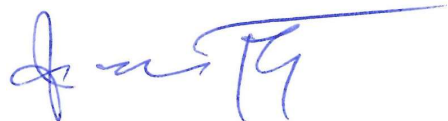
Lessor
