Description of the Defect : Subaru of America, Inc. (Subaru) is recalling certain 2008-2011 model year Subaru Impreza (except WRX/STI), 2008-2014MY Subaru Impreza WRX/STI, and 2009-2013 model year Subaru Forester vehicles, currently, or formerly, registered in Connecticut, Delaware, Illinois, Indiana, Iowa, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont, West Virginia, Wisconsin and the District of Columbia. Salt water could splash on the brake lines through a gap in the fuel tank protector, resulting in excessive corrosion of the brake lines. Due to incomplete repair instructions provided in the Subaru WQK-47 recall bulletin for Forester, Impreza, WRX, and STI vehicles, additional anti-corrosion material needs to be applied to the four-way joint connector area of the brake line system for vehicles previously repaired under NHTSA recall no. 14V-311 (Subaru Recall no. WQK-47). This recall, NHTSA No. 14V-830 (Subaru recall no. WQQ-52) is specific to affected Forester, Impreza, WRX, and STI customers who had their car remedied under NHTSA recall no. 14V-311 prior to December 23, 2014. Subaru has determined that this remedy was inadequate due to incomplete repair instructions provided to dealers. Affected Forester, Impreza, WRX, and STI vehicles that were not repaired under NHTSA recall no. 14V-311 prior to December 23, 2014 will continue to be processed under NHTSA recall no. 14V-311.

Note that affected vehicles not currently, or formerly registered, in the salt belt States identified above are eligible for repair, at no cost to the customer, upon request.

Description of the Safety Risk : Depending on driving conditions, salt water could splash on the brake lines through a gap in the fuel tank protector, resulting in excessive corrosion of the brake lines.

Brake fluid may leak from the perforated line(s). Since the center and rear brake lines work independently of one another, braking will still be possible if either (but not both) of the systems fail. The driver will be alerted to a fault in the brake system via illumination of the brake system warning telltale lamp because the fluid level will drop in the system. Failure of either the center or rear brake lines might cause the driver to misjudge the amount of brake pedal travel required to achieve the desired stopping distance.

November 13, 2014: Subaru's chemical supplier for the rust-proofing used in the WQK-47 recall contacted the National Parts Sales Manager with a concern about current inventory levels of the rust-proofing material (i.e. higher than expected).

November 14, 2014: FHI found that "Application of rust-proofing on 4-way connector" procedure was not complete in the Product Campaign Bulletin on affected Forester, Impreza, and Impreza WRX/STI vehicles.

November 19, 2014 to December, 2014: Subaru investigated the published repair procedure and vehicles already completed under NHTSA recall no. 14V-311.

December 16 2014: FHI concluded that Subaru will perform a safety recall in the U.S. market.
