On vehicles with a Genuine Mazda Accessory Trailer Hitch Harness installed, due to inappropriate routing of the harness, there may be an insufficient clearance between the harness and the main exhaust silencer. If the exhaust silencer makes contact with the harness while driving, harness damage may eventually occur causing harness wires to become short-circuited. Other than loss of trailer lighting, no other vehicle systems are affected.
