Subject: Fuel Gauge may Read Higher than Actual

This letter serves to acknowledge Bugatti's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Please review the following information to ensure that it conforms to your records as this information is being made available to the public. ## **Problem Description:**

Bugatti is recalling certain model year 2006-2010 Veyron vehicles manufactured March 10, 2006, to January 17, 2010 and 2010-2011 Veyron Grand Sport vehicles manufactured September 29, 2009, to June 30, 2010. In the affected vehicles, the fuel tank gauge may indicate that there is more fuel in the tank than there actually is.

## **Consequence:**

The inaccurate gauge may cause a driver to unexpectedly run out of fuel and the vehicle to stall, increasing the risk of a crash.

## **Remedy:**

Bugatti will notify owners, and dealers will replace the fuel tank control unit and upgrade the software, free of charge. The manufacturer has not yet provided a notification schedule. Owners may contact Volkswagen of America at 1-248-754-5000.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

The information in your report suggests that Bugatti may have been aware of this issue more than five business days before filing a report with NHTSA. Please be reminded that under Federal law, this agency is to be notified of all safety defect and/or noncompliance decisions within five business days. 49 CFR 573.6

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
