This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ford Motor Company has decided that your vehicle, with the VIN shown above, fails to conform to Federal Motor Vehicle Safety Standard (FMVSS) 102 for Transmission Shift Lever Sequence, Starter Interlock, Transmission Braking Effect and additional FMVSS standards governing warning indicators.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

What is the issue?	On your vehicle, immediately after engine start up at cold ambient temperatures, the transmission shift position indicator located in the instrument panel cluster may not illuminate and display the selected transmission gear position, increasing the risk of injury or crash from unintended vehicle movement. In addition, an inoperative instrument panel cluster display may prevent activation of certain warning chimes, messages and warning lights.
What will Ford and your dealer do?	Ford Motor Company has authorized your dealer to reprogram the instrument panel cluster free of charge (parts and labor).
How long will it take?	The time needed for this repair is less than one-half day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.
What should you do?	Please call your dealer without delay and request a service date for Recall 17C01. Provide the dealer with your VIN, which is printed near your name at the beginning of this letter.
	If you do not already have a servicing dealer, you can access <u>www.Fordowner.com</u> for dealer addresses, maps, and driving instructions.

What should you do? (continued)	Ford Motor Company wants you to have this recall completed on your vehicle. The vehicle owner is responsible for making arrangements to have the work completed. Ford Motor Company can deny coverage for any vehicle damage that may result from the failure to have this recall performed on a timely basis. Therefore, please have this recall performed as soon as possible.
	Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
	Your vehicle may be equipped with a diagnostic feature called the Vehicle Health Report which can inform you about all available recalls, as well as other key vehicle health information. Please see <u>https://owner.ford.com/vehicle-health</u> for more information.
What if you no longer own this vehicle?	If you no longer own this vehicle, and have an address for the current owner, please forward this letter to the new owner.
	You received this notice because government regulations require that notification be sent to the last known owner of record. Our records are based primarily on state registration and title data, which indicate that you are the current owner.
