## **Problem Description:**

Max-Trac Tire Co., Inc. (Max-Trac) is recalling certain Avon Viper Stryke tires, sizes 120/70R14, 120/70R15, 160/60R14, and 160/60R15, manufactured from January 4, 2015 through April 8, 2017. A bulge may develop in the tread or the tread may separate from the tire. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 119, "New Pneumatic Tires-Other than Passenger Cars."

# **Consequence:**

A bulge in the tread or a tread separation can cause a loss of vehicle control, increasing the risk of a crash.

#### Remedy:

Max-Trac will notify owners, and dealers will replace the tires, free of charge. The manufacturer has not yet provided a notification schedule. Owners may contact Avon Motorcycle Tyres North America at 1-800-642-7470 extension 3159. Max-Trac's number for this recall is 169.

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.

We have received Max-Trac's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
