**IMPORTANT SAFETY  
RECALL NOTICE**

Re: Trailer Tire Recall – NHTSA Recall Number 17T-017

Dear Sir or Madam,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Harbor Freight Tools (“HFT”) has concluded that certain Innova Ultra Runner and Far East brand trailer tires, sold individually or as a part of certain HFT utility trailer kits fail to conform to the requirements of Federal Motor Vehicle Safety Standard No. 119.

These products may not meet the strength requirements for trailer tires and could potentially increase the risk of a crash.

Our records reflect you may have purchased replacement trailer tires included in this recall campaign. The following trailer tires, sold individually, are included in this recall campaign:

The tires can be identified by the name of the tire manufacturer and the DOT serial number, also known as the Tire Identification Number, or TIN, found on the sidewall of each tire.



Please note, Innova Ultra Runner tires in other sizes are not affected by this recall and you may continue to use those tires.

As part of this notice, HFT will replace any of the tires described above with new utility trailer tires of the same size. **Replacement tires for sizes 4.80/4.00 x 12" and 4.80/4.00 x 8" will be available in HFT stores beginning December 13, 2017. Replacement tires for size 5.3 x 12" will be available beginning January 3, 2018.** You will need to remove the affected tires from your trailer. Bring only the tires to an HFT store for replacement. You will then need to install the replacement tires on your trailer. It is anticipated that removing the tires from your trailer and installing the new replacement tires should take approximately 1 hour.
