Attention Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act and the Canadian Motor Vehicle Safety Act.

Motor Coach Industries, Inc. has become aware that the air lines routed from the rear (primary) and front (secondary) air systems were misconnected on certain model year 2018 MCI J4500 coaches. As a result of the misconnections, the vehicle driver would not have the correct information regarding the status of the primary and secondary air pressure systems. For example, low air pressure in the primary air system would show as low air pressure in the secondary system in the instrument panel's gauges, which could cause the driver to delay reacting to and addressing the low air condition, and thereby increase the risk of a crash. If you are the lessor of the vehicle(s) identified above, Federal law requires that you forward this notice by first class mail to the most recent lessee(s) known to you, within ten days of your receipt of this notice.

If you have sold or otherwise transferred the vehicle(s) identified above, please contact the MCI Customer Service Line at 1-800-241-2947 with all of the information you have regarding the current owner/operator of the vehicle(s).

If you had your vehicle repaired for this condition prior to receipt of this notice and incurred any costs, you may be eligible for reimbursement. Please contact the MCI Customer Service Line at 1-800-241-2947 for further information in that regard.

We regret the inconvenience this may cause you, but urge you to implement the recall procedures with respect to your vehicle(s) as soon as possible for your added safety and satisfaction.
