

- a. If tight seating is ensured end measure.
- b. If the threaded connection of the spare wheel holder is loose continue to work procedure.





1. Remove caps (Figure 1 number 5)

2. Retighten bolts (Figure 1 number 6) of spare wheel holder to cross member / longitudinal member to 23 Reference WIS BA61.10-N-1002-01B
