

## IMPORTANT SAFETY RECALL NOTICE 17V757

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Gulf Stream Coach, Inc. has decided that a defect which relates to vehicle safety exists in the Federal ID label installed on your Model Year 2018 Model GV19FMB and SV19FMB Travel Trailer.

### **Problem Description:**

On certain 2018 model 19FMB [GV] Gulf Breeze and [SG] Geo Travel trailers manufactured by Gulf Stream Coach, Inc. ("Gulf Stream") the Recreational Vehicle Data Sheet. (Certification Weight Label) does not contain the correct information with regards to the number of axles installed on the trailer.

#### **Consequence:**

There is no safety risk contributed to this Recall with regards to the information within the applied Federal Weight Label with regards to GAWR Front Axle, Tire, Rim Size and Recommended Tire Pressure. The error as stated shows Duplicate information on the incorrect labels as applied to the "Rear Axle" which is not available on this model.

### Remedy:

A correct new label is enclosed to replace the original label. To install the new label, make sure the original label is removed from the vehicle, and then ensure that the area is clean and dry to promote adequate adhesion of the new replacement label. Remove the label backer exposing the adhesive backed label and put in place with applied pressure. Once label is installed, please return the enclosed postage paid card to complete this process.

# What if you no longer own the 2018 19FMB [GV] Gulf Breeze/ [SV] Geo travel trailer:

If you no longer own the identified above as being part of this Recall, please forward the new owner information to Gulf Stream at PO Box 1005 Nappanee, Indiana 46550, by completing the enclosed postage paid card so that Gulf Stream can contact the new owner and provide the replacement label.
