Dear Autocar Truck Owner:

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Autocar, LLC has decided that a defect which relates to motor vehicle safety exists in 2017-2018 model year Xpeditor chassis. These chassis were manufactured between 26 October 2016 and 14 November 2017, with non-sequential serial numbers in the range 223624 through 226270. Our records indicate that your vehicle was manufactured within this time period and may contain the defect described herein.

<u>MODELS AFFECTED:</u>	Autocar Xpeditor MY 2017-2018
<u>COMPONENTS AFFECTED:</u>	HVAC defrost mode door actuator
<u>SAFETY DEFECTS AND POTENTIAL RISKS:</u>	The HVAC defrost mode door actuator could overheat, which could lead to a fire, increasing the risk of personal injury or property damage.
<u>REPAIR REQUIRED:</u>	An additional harness with one-amp fuses will be added to the circuit.
<u>TIME REQUIRED FOR THE REPAIR:</u>	The labor time to repair your vehicle is 1.0 hours.
<u>WHAT YOU SHOULD DO:</u>	To have your vehicle repaired, contact your local authorized Autocar service site or email warranty@autocartruck.com .
<u>PRIOR REPAIRS:</u>	If you have previously paid for repairs relating to this recall you may be entitled to recover the amount you paid for those repairs. Submit a copy of all documentation supporting your claim to Autocar at the address set forth below in the "Assistance" section.
