#### SUBJECT: Model 253, Model Year 2016 and 2017 Headlight Adjustment

Daimler AG ("DAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain GLC vehicles (253 platform) the basic low beam headlamp setting may not correspond to current production specifications. As a result headlamp range may be reduced, increasing the risk of a crash. MBUSA will conduct a voluntary recall. An authorized Mercedes-Benz dealer will check the basic setting of the headlamps on the affected vehicles and correct it, if necessary.

Prior to performing this Recall Campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.

Please note that Recall Campaigns **do not expire** and may also be performed on a vehicle with a vehicle status indicator.

Approximately 8134 vehicles are involved.

#### Procedure

### 1. Check headlamp adjustment, correct if necessary (AP82.10-P-8260E).

**i** As an alternative, adjustment of the headlamps can also be performed with mobile headlamp adjusters on an appropriate level surface **(see AH82.10-P-1000-01A)** in this case *instead* of using the rail-guided devices specified in the WIS.
