Problem Description:

Kovatch Mobile Equipment Corp. (KME) is recalling certain KME Tip Mounted Lifting Devices, part numbers 95347115 and 95347118. The lifting devices do not meet the specified load rating or safety factor.

Consequence:

Using the device to lift the rated load may cause the device to deform, increasing the risk of injury.

Remedy:

KME has notified owners, and dealers will replace the tip mounted lifting device, free of charge. The recall began July 26, 2018. Owners may contact KME customer service at 1-800-235-3928.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
