Problem Description:

Federal-Mogul Motorparts LLC (Federal-Mogul) is recalling certain Tie Rod Ends, NAPA part number 269-6121, AC Delco part number 45A3098, McQuay-Norris part number ES4686E, Raybestos part number 410-1099, and Moog part numbers DS300044, DS800980A, and DS800981A. The crimped portion of the right hand outer tie rod replacement part may loosen allowing the inner and outer portions of the assembly to separate.

Consequence:

If the inner and outer portions separate, it can cause a loss of steering ability, increasing the risk of a crash.

Remedy:

Federal-Mogul will notify its distributors, and provide cards for the distributors to notify the customers that purchased the parts. The right hand outer tie rods subject to this recall installed on vehicles will be replaced at no cost to the vehicle owners. The recall is expected to begin August 8, 2018. Please be reminded of the following requirements:

You are required to submit a draft distributor notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final distributor notification letter and any subsequent distributor follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
