Subject: S3B School Bus Seat: 45" Restraint Seats

S3B 45" Restraint Seats manufactured February 5, 2018 through June 10, 2018

General Information

SynTec Seating Solutions, LLC has decided that a non-compliance with Federal Motor Vehicle Safety Standard FMVSS 210: Seat Belt Assembly Anchorages exists in certain school buses equipped with S3B 45" restraint school bus seats. The non-compliance was initially identified based on routine testing conducted at SynTec's manufacturing facility in High Point, North Carolina. The S3B 45" restraint seat failed to meet the testing requirements, allowing the floor mount foot to pull through the bolted joint above 4500 lbs. (5000 lbs. minimum requirement). The installation of a washer between the rear mounting foot and bus floor bolt heads increases surface contact of the bolted joint, preventing pull through.

There are approximately 37 vehicles and 235 seats involved in this campaign. The population is limited to 1 Dealer in 1 State with fewer than 10 total customers.

Additional Repairs

Dealers must complete all outstanding Recall campaigns prior to the sale or delivery of a vehicle. A Dealer will be liable for any progressive damage that results from failure to complete campaigns before sale or delivery of a vehicle.

Owners may be liable for any progressive damage that results from failure to complete campaigns within a reasonable time after receiving notification.
