Problem Description:

BMW of North America, LLC (BMW) is recalling certain BMW TurboCord Portable Chargers, part number 61442448670, and MINI TurboCord Portable Chargers, part number 61440003082. Capacitors within these charging systems may fail, possibly resulting in a shock hazard or a fire.

Consequence:

An electrical shock or a fire can increase the risk of injury or death.

Remedy:

BMW will notify owners, and dealers will inspect the charging cable, and replace it if necessary, free of charge. The recall is expected to begin November 12, 2018. Owners may contact BMW customer service at 1-800-525-7417 and MINI customer service at 1-866-825-1525.

We have received BMW's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
