The passenger side air bag inflator (recall 2318A) in this vehicle <u>must</u> be repaired at the same time as the driver side air bag inflator. Note: The driver side airbag inflator in your vehicle may be part of a small population of inflators that pose a higher risk of <u>explosion</u> in the event of a crash that causes an air bag deployment. Two inflators built at Takata on the same day as the driver side air bag inflator in your vehicle have <u>exploded</u> causing fatal injuries. An inflator explosion could result in <u>sharp</u> metal fragments striking the driver or other vehicle occupants, resulting in <u>SERIOUS INJURY OR DEATH.</u>
