IMPORTANT RECALL INFORMATION UPDATE

On Friday June 22, 2018, MBUSA launched 49,287 vehicles under Recall Campaign 2018060011 for Priority Group 5 as required. Please be advised, however, that we do not yet have sufficient quantities of replacement airbags to launch the recall for the remainder of the PG4 C-Class (W204) vehicles in Zone A as well as for several PG5 models. Accordingly, MBUSA has filed an extension request with the National Highway Traffic Safety Administration for those models.

The table on the following page reflects both the revised anticipated launch dates as well as the current replacement airbag production schedules. We continue to work closely with airbag manufacturers to increase availability and optimize launch schedules, and will continue to provide updated information as it becomes available.

Part Availability Look-up Tool

Customers actively following part availability for their vehicle(s) may raise questions about the revised schedule. The Part Availability Look-up Tool on www.mbusa.com/recall has been updated to reflect the launch dates shown in the table below. Please note, however, that for certain models identified with (**), the tool currently displays the month at the end of the quarter which differs from the table. This is due to a programming issue in the tool which is being corrected.

The table below reflects the most accurate information, and should be used as a reference until the Look-up Tool is corrected in the event a customer has a question. When final remedy parts are available, customer letters will be issued according to the target dates in the attached table.
