Description of the Noncompliance : Recalled vehicles are equipped with at least one three-place seat having Type 1 seat belts and are built with the floor structure that failed the Federal Motor Vehicle Safety Standards (FMVSS) number 207, "Seating systems" and number 210, "Seat belt assembly anchorages" test

A second test confirmed the results and it was concluded that 3-place seats equipped with at least one Type 1 seat belt may not be compliant with the requirements of the Federal Motor Vehicle Safety Standard (FMVSS) number 207, "Seating systems" and number 210, "Seat belt assembly anchorages."
