January 16, 2018: VWAG received information from the factory about potentially incorrect steering wheel/ airbag modules that had been installed in vehicles built for the United States market. A stop order was immediately initiated and analysis began to evaluate cause and possible consequences. February 02, 2018: The topic was presented in Volkswagen AG's Product Safety Committee and a determination of defect / non-compliance was made.

Description of Remedy:

Description of Remedy Program: Replace both the steering wheel and the driver frontal airbag module in

affected vehicles. The steering wheel must be replaced because the correct airbag for the U.S. market is not compatible with the existing steering wheel that was installed in the vehicle. Because all affected vehicles are still covered under New Vehicle Limited Warranty, no reimbursement

program is planned for this recall.
