Descriptive Information : Review of Federal Data Certification labels for production of the Geo/ Matrix models was completed upon discovery of the apparent typo error of the rear axle Kg rating.

Description of Noncompliance :

Description of the Noncompliance : On certain 2018 model Geo / Matrix G280TB and Geo 293RK Travel trailers manufactured by Gulf Stream Coach, Inc. ("Gulfstream") the Recreational Vehicle Data Sheet. (Federal Certification Label) does not contain the correct information with regards to the (Kg) Kilogram weight rating of the secondary axle. All other information for both the front and rear axles are correct regarding the GAWR for both axles, and the Kg rating of the front axle.

FMVSS 1 : 567 - Certification

FMVSS 2 : NR

Description of the Safety Risk : The Kg rating only of the rear axle [second axle] is understated by 182 Kg [401.31 lbs.] The numeric rating of the rear axle of 4400 lbs. as posted is correct. Relying on the Kg rating only would be under the rating of the rear axle, and therefore would not pose as a safety risk.

Description of the Cause : The information regarding the trailers Kg rating of the rear axle was inadvertently entered into the program [typographical error] which is used to generate the Federal Identification Label.

Chronology :

Gulf Stream Coach identified the error in processing the Federal Identification Labels during a recent audit of production application of the required labeling. (15) Fifteen incorrect labels were installed and those trailers shipped prior to identifying the error. In addition (8) units were identified at manufacturing facility and correct labels have been installed prior to shipping.

Description of Remedy :

Description of Remedy Program : Gulf Stream Coach, Inc will provide free of charge the correct labels which will be mailed to (9) nine dealers and one retail registered owner on record as of the time of this recall.

How Remedy Component Differs from Recalled Component : Corrected label identifies correct (Kg) rating of 1996 Kg for the 4400 lbs. GAWR axles installed on these trailers.

Identify How/When Recall Condition was Corrected in Production : Immediately upon discovery and corrective actions taken to evaluate the scope and identity of the universe of the potentially affect trailers.
