Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2018 Keystone Hideout, Passport, Summerland Travel Trailers, 2018 Dutchmen Aspen Trail, Coleman Travel Trailers, and 2018 Crossroads Zinger Travel Trailers. As a result, Keystone RV is conducting a safety recall.

Reason for This Recall

It has been decided that the vehicles in the recall population have a Norcold N306 refrigerator (mini refrigerator) with a gas valve test port screw that may be loose or missing. When using the Norcold mini refrigerator on "Gas" mode if the test port screw is loose or missing propane gas can leak from the gas valve. If propane gas leaks during use it can be ignited, leading to an increased risk of personal injury and/or property damage. The vehicles included in the recall are:
