## **Problem Description:**

Morgan Truck Bodies LLC (Morgan) is recalling all 2013-2018 Morgan Truck Bodies built on Isuzu, Kenworth, Mercedes, Chevrolet, GM, Freightliner, Mitsubishi and Peterbilt chassis. Water may enter part of the wiring harness and affect the turn signal operation.

## **Consequence:**

Incorrect turn signal operation may increase the risk of a crash.

## **Remedy:**

Morgan will notify owners, and dealers will replace or modify the affected wiring harness, free of charge. The recall is expected to begin March 15, 2018. Owners may contact Morgan customer service at 1-800-666-7426. Morgan's numbers for this recall are FRWI-517 and FRWI-518.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

The information in your report suggests that Morgan may have been aware of this issue more than five business days before filing a report with NHTSA. Please be reminded that under Federal law, this agency is to be notified of all safety defect and/or noncompliance decisions within five business days. 49 CFR 573.6

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
