The issue may be due to a missing relay or inconsistencies with the splicing directions and mismatched wire color codes.

At the end of November 2017 a dealership reported that a group of new buses could be moved while the wheelchair lift was in operation. DTNA began an investigation to understand the potential consequences and determine the scope of the issue. In March 2018 DTNA decided to voluntarily recall certain Thomas Built Buses equipped with wheelchair lifts.
