Description of the Defect :	Reference recall 16V-809, this filing is a population extension of a previous recall which states, "On certain FCCC RV chassis, a power steering hose may be routed with inadequate clearance between the hose and a power stud on the starter motor. This reduced clearance may cause the hose, which is a metallic braid with rubber coating, to rub against the power stud on the starter potentially leading to arcing and in addition may cause a power steering fluid leak."

In October 2016 DTNA decided to conduct a voluntary safety recall on certain RV chassis with inadequate clearance. In November of 2017 an RV outside of the original population experienced a thermal event and began an investigation. In March of 2018 DTNA decided to expand the population for certain RV chassis with inadequate clearance.
