Dear «OWNER\_NAME»:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2016-2017 Crossroads Redwood Fifth Wheels. As a result, Keystone RV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall	It has been decided that the vehicles in the recall population may have been manufactured with a rear window that is identified with an exit sticker and the rear window is intended as the secondary emergency exit and may be blocked by the rear ladder. If an emergency situation arises and the occupants of the vehicle attempt to use the rear window as an emergency exit point they will not be able to exit as the rear ladder blocks the emergency egress point resulting in an increased risk of personal injury.
What we will do	The remedy is to remove the emergency exit sticker if the emergency egress window is blocked by the ladder. If you need assistance in inspecting the window or removing the exit sticker please contact a Keystone dealer and the remedy will be performed at no charge.
What we need you to do	<ul> <li>As soon as possible, please e-mail ownerrelations@keystonerv.com or call 1-866-425-4369. We will need the following information:</li> <li>VIN</li> <li>Name, address and phone number</li> <li>A photo showing the sticker is removed on the affected window or showing the emergency egress window is not blocked by the ladder.</li> </ul>
