**Problem Description** 

Gas bubbles may form in the brake system due to insufficient chrome coating of the brake caliper pistons. If this happens, braking performance may be reduced which can increase the risk of a crash.

**Corrective Action** 

Replace the rear brake calipers.

#### **Stop-Drive Information**

- Volkswagen has issued an urgent stop-drive notice for affected vehicles. Affected vehicles should NOT be driven until the recall repair has been completed.
- Owners are advised: DO NOT DRIVE THE VEHICLE; contact VW Roadside Assistance at 1-800-411-6688 to make arrangements for the vehicle to be towed to an authorized Volkswagen dealer.
- Provide a FREE loaner vehicle for affected owners if necessary.
- Quarantine all affected vehicles in dealer inventory (including those being used by dealership personnel or as demonstrator vehicles) until they are repaired.

Parts will not be allocated prior to owner notification. If you need to order parts to support this recall repair, please contact the Parts Specialists via phone (800-767-6552), email (VWoAPartsSpecialists@vw.com) or chat with the VIN to order. Orders without an affected VIN will not be supported.

#### **Code Visibility**

On or about June 22, 2018, affected vehicles will be listed on the Inventory Vehicle Open Campaign Action report under My Dealership Reports (found on <a href="www.vwhub.com">www.vwhub.com</a> & OMD Web). A list will not be posted for dealers who do not have any affected vehicles.


#### Section B - Replacing Rear Calipers or Caliper Assemblies



- · Remove the rear wheels.
- Push the lever on the brake caliper <2> in the direction of the <arrow>.
- Disengage the parking brake cable <1> from the lever on the brake caliper.
- Squeeze the retainers <3>.
- Remove the parking brake cable <1> from the bracket on the brake caliper <4>.



 Connect the bleed hose <1> from the bleeder bottle to one of the calipers being replaced and open the bleed valve.



- Install the -VAG1869/2-.
- Close the bleeder valve and remove the bleeder bottle.


# U NOTE

By doing this, the valves in the brake master cylinder are closed and the brake fluid reservoir does not run empty. Also, no fluid will drain out of the brake hose once it is removed from the caliper.

- Gravity bleed the new brake calipers:
  - Attach a hose to each caliper bleeder valve.
  - Open the bleeder valve on each caliper.
  - Once fluid starts to flow out of the bleeder valve, close the valve.

Seq.	Caliper Position	Amount of fluid to be removed
1	Left Rear	200 ml
2	Right Rear	200 ml

- Use a suitable bleeder hose. It must fit tightly on the bleeder valve so that no air can get into the brake system.
- After each caliper is bled, torque the bleeder valve to 10 Nm and install protective cap.
- Install wheels and torque wheel bolts to 120 Nm.
