Subject: Engine may Stall at Low RPM while Downshifting

This letter serves to acknowledge Automobili Lamborghini's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Automobili Lamborghini (Lamborghini) is recalling certain 2012-2018 Lamborghini Aventador Coupe and Roadster vehicles. The engine may stall unexpectedly during certain driving conditions such as when the accelerator pedal is released below 2000 rpms while the transmission is automatically down shifting to a lower gear.

Consequence:

An engine stall can increase the risk of a crash.

Remedy:

Lamborghini will notify owners, and dealers will install updated engine software, free of charge. The recall is expected to begin August 3, 2018. Owners may contact Lamborghini customer service at 1-866-681-6276. Lamborghini's number for this recall is L73X-R.02.18.

We have received Lamborghini's proposed owner notification letter and we request a revised version. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Please be reminded that it is required that owners be notified of a safety defect in their vehicles within 60 days of a manufacturer's notification to NHTSA of a safety defect in those vehicles. The date that you provided in your Defect Information report exceeds 60 days.

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
