Additionally it states that "In affected tires, there may be a risk of exposure of steel body cores in the sidewall to the environment, which could lead to deterioration of the cords in that area."

Bridgestone documentation states that, "If a rapid air loss occurs due to that condition while the vehicle is operating, there may be an increased risk of a crash."
