It was determined from an extensive review of failed product that all the axles in question were produced on a one production line. This line started locating ungreased bearings at the line on November 7, 2018. The corrective actions were put into place on February 26, 2019. All axles assembled on this line that are included in this recall population have hubs that would have allowed for an ungreased bearing to be installed when a pre-greased bearing was required.

Description of Defect:

Description of the Defect: There was insufficient grease on the inner and outer bearings of some of the

hubs on some of the axles produced in the time period of 11-07-18 to 02-26-19.

Description of the Safety Risk: Bearing life can be reduced, leading to premature bearing failure. This can, in

turn, lead to the wheel end overheating.

Description of the Cause: Bearings that were not pre-greased were installed in hubs that require the

bearings to be pre-greased. Bearings that are not pre-greased are meant to be installed in "oil bath" hubs (hubs that are filled with oil to lubricate the inner and outer bearings). Bearings that are pre-greased are to be installed in hubs that use grease as the bearing lubricant. Hubs that use grease as the bearing

lubricant do however have some grease in the hub cavity, in addition the

grease that might be missing on the inner and outer bearings,

Identification of Any Warning A wheel end with an insufficient amount of grease can overheat (run hot) or that can Occur: make nose during trailer operation.

Chronology:

Initially, several axles were discovered, by our service teams and customers, that did not have greased bearings. More inspections revealed that a larger number of axles, all from the same production line, had hubs with un-greased bearings (in applications where greased bearings are required). The cause of this error, along with the potential number of axles with this conditions was determined, and it was also determined that there was a noncompliance.

Description of Remedy:

Description of Remedy Program: If the axles have not been installed on a trailer, the remedy will be to

repack the bearings and reinstall the hubs on the axles. If the axles have been installed on a trailer, either (1) the hubs (including bearing cups and cones) will be properly greased and replaced on the axles, or, (2) new bearing cups will be installed in the existing hubs the bearing cones will be

replaced and properly greased, and the hubs will reinstalled on the axles.

How Remedy Component Differs The remedy components (hubs for the #13, #13D, #13G, #13T, #14, #14T
