7/16/2019 we noticed that inventory was off on a bolt. After researching, we realized that the incorrect bolt may have been used in the wedge kit. The safety committee agreed that this was a safety related item and agreed that a recall was necessary.

**Description of Remedy :**

Description of Remedy Program : MORryde is issuing a safety recall for inspection of the bolts used in the wedge kits. MORryde will pay for the inspection and the replacement bolt, if needed.

How Remedy Component Differs from Recalled Component : The correct bolt length based on the wedge kit ordered.
