Descriptive Information: Some Ram 1500 electric power steering ("EPS") gears may have been built with a

contaminated circuit card assembly that may short circuit, potentially resulting

in an intermittent loss of power steering assist.

Supplier production records were used to identify the EPS gears potentially built with contaminated circuit card assemblies. The scope was determined by the number of parts shipped from the supplier to Mopar parts depots during the

suspect period.

Similar EPS gears not included in the recall were manufactured with a circuit

card assembly that is not contaminated.

### **Chronology:**

- On October 18, 2019, FCA US LLC ("FCA US") Current Quality notified the FCA US Vehicle Safety and Regulatory Compliance ("VSRC") organization of September 2019 warranty claims of vehicles experiencing intermittent loss of power steering assist related to the EPS gear.
- On October 30, 2019, the FCA US VSRC organization opened an investigation as a result of a vehicle evaluation with a suspect EPS gear which exhibited the intermittent loss of power steering assist condition.
- Between October 18, 2019, and October 30, 2019, FCA US VSRC, FCA US Engineering, and the supplier, met to review the issue, the potential safety consequence, and understand the suspected scope of EPS gears affected.
- As of November 5, 2019, FCA US has identified zero CAIRs and five field reports related to this issue.
- As of November 5, 2019, FCA US total warranty is 39 at 202 c/1000 for this issue.
- As of November 5, 2019, FCA US is not aware of any accidents or injuries potentially related to this issue.
- On November 7, 2019, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected EPS gears.

## **Description of Remedy:**

Description of Remedy Program: FCA US will conduct a Voluntary Safety Recall to replace the contaminated

EPS gear assembly with an EPS gear assembly that is not contaminated.

FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
