Description of the The DOT certification symbol which precedes the TIN (Tire Identification

Noncompliance: Number) has not been molded onto either the intended outboard or inboard

sidewall. The tire is not marked with the required UTQG treadwear, traction or

temperature gradings as illustrated in Figure 1 of 49 CFR 575.104.

Description of the Safety Risk: All markings other than DOT symbol specified by 49 CFR Part 571.139 are

present on the sidewall(s), and in compliance with 49 CFR Part 571.139. The subject tire fully complies with the performance requirements of 49 CFR 571.139. However, without the DOT symbol on the sidewall, the tire contains

no declaration as to its certification.

Description of the Cause: Two versions of the Michelin CrossClimate+ 225/60R17 103V XL ran

concurrently at Michelin's Vitoria, Spain production site. One version was marked correctly for the US market, and the other was marked for the

European market. Michelin's European Araia distribution center erroneously accepted one pallet of tires marked for the European market as the US approved version. The pallet was subsequently misidentified in Michelin's logistics systems, and this allowed it to ship to a US Michelin distribution center.

Chronology:

September 2019: Initial alert from Tire Rack, fifteen subject tires with letters DOT missing from TIN. Tires were returned to Michelin and quarantined. Actions were launched to determine whether there could be other similar tires in the US market.

October 2019: Analysis of inventory and sales records, production records and tire specifications. Vitoria plant executed root cause analysis, determined that the event was limited to one pallet of 32 tires. Vitoria also determined that the UTQG markings were also missing from the affected tires.

November/December 2019: After inspection of 987 subject tires in Europe, and 3,270 subject tires in North America, 20 of the 32 affected tires have been located and are quarantined under Michelin control, leaving the potential for up to 12 non-compliant subject tires to still be present in the US.

Description of Remedy:

Description of Remedy Program: MNA will initiate a voluntary noncompliance recall of the subject tires. The owners that may have purchased tires of the specified date range will be contacted by first class mail beginning the week of January 30, 2020. This correspondence will explain the issue and include specific instructions on how to obtain replacement of the improperly marked tires. Owners may contact Michelin at 1-888-847-8475. All noncompliant tires under Michelin control will be scrapped.
