**Descriptive Information :** - The recall population was determined by a review of vehicle records of the labels that were printed. - The information on the labels did not match the tires on the trailers. - The affected product is the Airstream/Basecamp X/Model Year 2019, available in the United States and Canada.

**Description of the Noncompliance :** The tire information printed on the Federal Certification label and Tire Placard are incorrect. The information printed was for 235/55R18 Load Range D tires with 80 psi, when it should have been for 235/75R15 Load Range D tires with 51 psi.

FMVSS 1 : 110 - Tire selection and rims

FMVSS 2 : 567 - Certification

**Description of the Safety Risk :** Per the information contained on the labels, an owner could overinflate their tires installed on the trailer. This noncompliance can cause a vehicle crash without prior warning. If this warning is not heeded, a vehicle crash can occur.

**Description of the Cause :** The tire information for the Basecamp X differs from the Basecamp because the tire size being installed on the Basecamp X is a larger "off-road" style tire.

**Chronology :**

November 26, 2018 - Quality Control inspection discovered incorrect labels were being printed and placed on certain trailers. November 27, 2018 - The Basecamp model was identified as having incorrect labels. November 29, 2018 - Investigation was started of labeling for prior 10 model years across all vehicles produced by Airstream. December 5, 2018 - Basecamp X Model was corrected in production and all units on premises were corrected. January 2, 2019 - Investigation into prior model year labeling was concluded. January 3, 2019 - 573 submitted to NHTSA for affected Basecamp X model.

**Description of Remedy :**

Description of Remedy Program : Corrected labels will be sent to affected customers and dealers for installation. This will be done at no cost to the owner.

How Remedy Component Differs from Recalled Component : The tire information has been corrected from 235/55R15 with 80 psi to 235/75R15 with 51 psi.

Identify How/When Recall Condition was Corrected in Production : The issue was corrected on December 5th, 2018.
