Problem Description:

Vantage Mobility International, LLC (Vantage) is recalling certain 2014-2017 AMS Edge II vehicles. The fuel pump gasket may deteriorate, allowing fuel to leak. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 301, "Fuel System Integrity."

Consequence:

A fuel leak in the presence of an ignition source can increase the risk of a fire.

Remedy:

Vantage has notified owners, and repair facilities will replace the fuel tank with a redesigned fuel tank, free of charge. The recall began on January 28, 2019. Owners may contact Vantage customer service at 1-800-488-9082.

It is our understanding that notification to owners began on January 28, 2019, prior to our review of the owner notification letter. Should it become necessary for Vantage to do a renotification, the follow-up notification must be submitted to this office for review and it must comply with the requirements of Part 577.5, "Notification pursuant to a manufacturer's decision" and Part 577.10, "Follow-up notification."

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

The information in your report suggests that Vantage may have been aware of this issue more than five business days before filing a report with NHTSA. Please be reminded that under Federal law, this agency is to be notified of all safety defect and/or noncompliance decisions within five business days. 49 CFR 573.6

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
