Description of the Defect : The vehicles involved are equipped with a fuel vapor separator which, due to a manufacturing fault caused by the supplier, may cause the fuel to evaporate and the vehicle to ignite.

Description of the Safety Risk : The defect may cause a potential fuel vapor leak and/or fire.

Description of the Cause : The plastic weld in the Fuel Vapor Separator may crack due to the manufacturing process.

How Remedy Component Differs from Recalled Component : The correct component is identified with a label (not present in the defective components) and through specific production date of each batch to guarantee the traceability.  
Identify How/When Recall Condition was Corrected in Production : The defect was corrected by the supplier & implemented on the assembly line, starting with VIN # ZFF89FPA3K0241176.
