Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2019 Alpine, 2018-2019 Avalanche, 2019 High Country Montana, and 2018-2019 Montana Fifth Wheels. As a result, Keystone RV is conducting a safety recall.

Reason for This Recall

It has been decided that the vehicles in the recall population have a MORryde cargo tray that may have insufficient fasteners used on the stop bracket. Under certain conditions when enough force is applied while opening the MORryde cargo tray, the fasteners may fail and the tray will not stop, allowing it to come all the way out of the compartment it is mounted in. This situation may lead to an increased risk of personal injury. The vehicles included in the recall are:
