Description of the Defect: This recall involves the front brake hose. After repeated cycling of the

handlebars to the maximum left steering angle, which occurs when locking the handlebars or in tight maneuvers, the hose at the location of the connection fitting could become damaged. After additional cycling, the hose could leak.

Description of the Safety Risk: If a brake fluid leak occurs, the maximum front brake pressure may not be

able to be applied. This would reduce braking capability, and could increase the risk of a crash. The rear brake, which is controlled by the hand brake

lever, remains fully operational.
