Description of the Defect : The Capital LP Gas Drop-in 2 Burner cooktop does not perform safely in this application.

Description of the Safety Risk : When the furnace is running, the cooktop's flame can become inverted. Excessive heat buildup then occurs which poses a burn hazard.

Description of the Cause : In the current installation the cooktop becomes very sensitive to air drafts.

**Chronology :**

2/1/2019 - Dealer report of a problem with a Capital LP Gas Drop-in 2 Burner cooktop during a PDI inspection. KZ RV contacts DDR and forwards the reported problem. DDR states that the issue originated from a DDR installed gas fitting and that the issue is uncommon and caused by a faulty gas fitting that they have stopped using.

2/4/2019 - Dealer files another claim for the same issue on a second unit. DDR instructs KZ RV to replace both cooktops with newly designed cooktops. KZ RV verifies all new units have this new design cooktops which do not utilize this fitting. KZ RV to continue monitoring the issue.

2/21/19 - Dealer reports of two additional units that have issue during PDI inspection. KZ RV conducts testing on current cooktop.

2/22/19 - Testing is conducted on KZ RV units and various issues with performance are recorded.

2/23/19 thru 2/26/19 - Testing is performed to validate previous findings.

2/27/19 - Safety committee meets and agrees safety issue is present and votes to issue a recall.

**Description of Remedy :**

Description of Remedy Program : Switch out the Capital LP Gas Drop-in 2 Burner cooktop with a comparable model manufactured by Suburban.

How Remedy Component Differs : The Suburban cooktop has additional ventilation holes in the cooktop's

from Recalled Component : surface that provide proper airflow to both additional appliances and the cooktop's burners that prevent an inverted flame.

Identify How/When Recall Condition was Corrected in Production : The Capital LP Gas Drop-in 2 Burner cooktop has been replaced in production with the Suburban cooktop.
