Dear Sir or Madam:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

M. H. EBY has decided that a potential safety defect exists in certain axles provided by Dexter Axle Company. Accordingly a recall to address this issue is being initiated effective March 8, 2019.

The defect involves an insufficient amount of grease applied to bearings on some axles manufactured by Dexter Axle Company between November 7, 2018 and February 26, 2019. This may result in overheating and premature bearing failure. Attached please find detailed instruction from Dexter Axle how to have the wheel –end service properly inspected and re-greased. M H EBY will supply to the owner of the trailer all replacement parts. There is no cost to the owner for this recall. In the event your current service facility cannot attend to this in a timely manner, Dexter Axle has mobile teams available to be dispatched to you. Please contact M H EBY Warranty department at 717-354-1458 to make arrangements to utilize this service.

To be reimbursed for your expense to have the axles checked and bearings repacked or replaced you must submit a paid receipt to:
