

## **IMPORTANT SAFETY RECALL**

July 2019

## This notice applies to your 2017 - 2019 model year Chervrolet Trax. The applicable Vehicle Identification Number (VIN) can be found on the address label of the envelope.

Dear General Motors Customer:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Previously, you were notified that your 2017 - 2019 model year Chevrolet Trax was involved in GM recall A182202370. This letter is to inform you that parts are now available to repair your vehicle.

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2017 - 2019 model year Chevrolet Trax. As a result, GM is conducting a safety recall. We apologize for this inconvenience. However, we are concerned about your safety and continued satisfaction with our products.

## IMPORTANT

- Your vehicle is involved in GM recall A182202370.
- Schedule an appointment with your Chevrolet dealer.
- This service will be performed for you at **no charge**.

Why is your vehicle being recalled?	In some of these vehicles, a joint in one or both front lower-control arms may have been improperly welded. Over time, an improperly welded joint can fatigue and break, causing the lower-control arm to partially separate from the vehicle. If a lower-control arm partially separates from the vehicle, the front wheel attached to the control arm will toe outward, adversely affecting the vehicle's steering and potentially causing the tire to rub against the wheel well, increasing the risk of a crash.
What will we do?	Your Chevrolet dealer will inspect left and right lower-control arms and replace the front lower-control arm assembly if necessary. This service will be performed for you at <b>no charge</b> . Because of service scheduling requirements, it is likely that your dealer will need your vehicle longer than the actual inspection and service correction time of approximately 1 hour and 47 minutes.
What should you do?	You should contact your Chevrolet dealer to arrange a service appointment as soon as possible.
Did you already pay for this repair?	Even though you may have previously had repairs for this condition, you will still need to take your vehicle to your dealer for additional repairs. If you have already paid for repairs for the condition described in this letter, please complete the enclosed reimbursement form and present it to your dealer with all required documents. Working with your dealer will expedite your request, however, if this is not convenient, you may mail the completed

reimbursement form and all required documents to Reimbursement Department, PO Box 33170, Detroit, MI 48232-5170. The completed form and required documents must be presented to your dealer or received by the Reimbursement Department by July 31, 2020, unless state law specifies a longer reimbursement period.
