Description of the Defect: Affected vehicles have an electric water pump that circulates cooling water to

cool the fuel cell stack. The magnets attached to the rotor core inside the electric water pump were not properly surface-treated and may corrode from

water exposure.

Description of the Safety Risk: Excessive magnet corrosion can disable the electric water pump, which would

illuminate the warning indicator and cause the vehicle to enter EV limp mode or lose motive power and come to a stop, thereby increasing the risk of a

#### **Chronology:**

April 2, 2018

Honda received the first report in which the "Power System" warning light illuminated on the multiinformation display and began an investigation.

June 2018

Honda received a second report in which the warning message illuminated. Returned failed parts analysis indicated that the magnets on the rotor core were corroded and cracked.

October 2018 to January 2019

Analysis and testing suspected that the cause of magnet corrosion was manufacturing-related. Durability testing was performed on magnets that were treated with anti-corrosive coating and confirmed the magnets were resistant to corrosion.

February to March 2019

Analysis of healthy parts collected from the field affirmed that the two prior reports were reproducible and that the magnets were susceptible to corrosion.

April 11, 2019

Honda determined that a defect related to motor vehicle safety existed and decided to conduct a safety recall.

As of April 11, 2019, Honda has received two warranty claims, nine field reports, and no reports of injuries or crashes related to this issue.

## **Description of Remedy:**

Description of Remedy Program: Registered owners of all affected vehicles will be contacted by mail and

asked to take their vehicle to a Honda automobile dealer. The dealer will replace the electric water pump, for free. Because the new vehicle limited warranty on all affected vehicles would have provided a free repair for the problem addressed by this recall, without any payment by the owner,

reimbursement for pre-notification repairs will not be offered.
