IMPORTANT SAFETY RECALL

Certain 2010 - 2016 Model Year Porsche Panamera Vehicles
Checking control unit for air-conditioning blower and replacing if necessary

Dear Mr.

This notice is sent to you in accordance with the <u>National Traffic and Motor Vehicle Safety Act</u>. Porsche has decided that a defect that relates to motor vehicle safety exists in certain 2010-2016 Porsche Panamera vehicles.

You received this notice because our records indicate that you are the current owner of a vehicle affected by this recall.

What is the issue?

There is a possibility of water intrusion into the air-conditioning unit in your vehicle, which could potentially cause a short circuit. If this occurs, it could result in a fire, even after the vehicle is parked and shut off.

What will Porsche do?

Porsche is conducting a safety recall to inspect and replace the blower control unit with an optimized unit, if necessary. This service will be performed free of charge. The remedy parts are now available for installation at your authorized Porsche dealer.

What should you do?

Please contact any authorized Porsche dealer to schedule an appointment to have the remedy performed as soon as possible and to arrange for alternate transportation during the repair period, if needed.

NOTE: Until you have the remedy performed, as a precaution, we ask that you please park your Panamera only outdoors (not in the garage), and away from other vehicles and structures, especially overnight.

This is an important Safety Recall.

The remedy will take approximately 30 minutes for inspection. If a repair is required, the repair will take an additional 70 minutes. This recall will be carried out at no expense to you. If you have previously paid to have this repair performed, you may be eligible for reimbursement. For more information, please contact customer commitment as instructed below.

What if you are not the owner or operator of this vehicle?

If you are the lessor and registered owner of the vehicle identified in this action, the law requires you to forward this letter immediately via first-class mail to the lessee within ten days of receipt of this notice.

If you have changed your address or sold the vehicle, please fill out the enclosed prepaid Owner Reply Card and mail it to us so we can update our records.
