4/10/2019 - Investigation opened to determine cause and scope of the failures.

5/16/2019 – Keystone Safety Committee reviewed the information gathered from the cause and scope investigation. Information concluded that the data reviewed indicated a unanimous vote for a voluntary recall concerning only Fuzion 429 model because of the configuration and wire routing on this particular floor plan. Investigation called for to determine affected unit range.

5/17/2019 - Investigation concluded and scope completed
