## **Description of Noncompliance:**

Description of the FMVSS 214 (Side Impact Protection) specifies crush resistance requirements Noncompliance: based on deflections of the side doors under specified loading conditions. During a routine inspection at the assembly plant, it was discovered that the upper intrusion bracket (bar) in the front left door of certain 2018 Karma Revero vehicles contained a segment of split metal at or near the B pillar section of the inner door.

All front and rear doors of all 2018 Karma Revero vehicles at the assembly plant were inspected and the split metal condition was detected only in the front left door of certain vehicles. All left front doors found with the condition were replaced with new front doors at the assembly plant.

FMVSS 1: 214 - Side impact protection

FMVSS 2: NR

Description of the Safety Risk: If the left front door intrusion bars do not perform as designed due to a split

Description of the Safety Risk: in the metal, the affected vehicles may not be able to meet the FMVSS 214 side

impact protection requirements, thus increasing the risk of injury to vehicle

occupants.

Description of the Cause: Certain upper intrusion brackets received from the component manufacturer

contained split metal at or near the B pillar section of the inner door.

Identification of Any Warning The driver and vehicle occupants do not get any warning, though no such

that can Occur: warning is required by FMVSS 214.

#### **Chronology:**

On May 7, 2019, it was discovered that the upper intrusion bracket (bar) in the left front door in certain MY 2018 Karma Revero vehicles contained a segment of split metal at or near the B pillar section of those doors. The vehicles were put on hold at the assembly plant and fixed. This discovery led Karma to determine that certain MY 2018 Karma Revero vehicles in the field might have similar upper intrusion bar concerns. Based on the loads associated with side impact events, and the tendency of the split metal to propagate during those events, this could render those MY 2018 vehicles potentially non-compliant with FMVSS 214.

After inspecting 116 vehicles at the assembly plant, only two front left doors were found with split metal in the upper intrusion bracket. These findings were promptly communicated to Karma's Engineering Management and Field Action Executive Committee (FAEC) and an investigation was immediately conducted by the Karma Quality and Engineering staff.

On May 24, 2019, after completion of the investigation, the FAEC met to discuss the preliminary results of the investigation. On May 28, 2019, the FAEC decided to recall all affected vehicles.

As of May 31, 2019, Karma has not received any field reports, warranty claims, or reports of injuries or deaths related to this matter.

#### **Description of Remedy:**

Description of Remedy Program: The remedy is to inspect all front doors. Any front doors found containing

an affected upper intrusion bracket (bar) will be replaced. Registered owners of all affected vehicles will be notification of the recall in July 2019, at which point they will be asked to take their vehicle to a Karma

authorized repair center where the remedy will be provided free of charge.

The affected vehicles are new and are covered under the manufacturer owner's warranty program. Therefore, pre-notice reimbursement to

owners will not be necessary.

How Remedy Component Differs Any front doors identified as containing an affected upper intrusion

from Recalled Component: bracket (bar) with a segment of split metal will be replaced with a new

door containing upper intrusion bracket (bar) with no splits.

Identify How/When Recall Condition All 2018 MY vehicles remaining in Karma's possession were put on hold was Corrected in Production: and subsequently have been repaired. Additionally, all non-compliant

parts were removed from the assembly plant's inventory and all doors in

stock passed quality inspections.

2018 model year vehicles in their inventory.
