This notice applies to your vehicle: 5TDKZ

Dear Valued BraunAbility Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

BraunAbility has decided that certain BraunAbility Toyota Sienna rear entry conversions manufactured from January 9, 2018 May 20, 2019 may have been assembled with a supplied brake line fitting that was not built to specification. The risk is that overtime, the union may develop a brake fluid leak causing potential braking degradation, increasing the chance of a crash.

The remedy is to schedule an appointment with your local BraunAbility dealer to inspect your vehicle. If inspection reveals a repair is necessary, the BraunAbility dealer will add an adapter fitting to the brake line. The repair should take approximately one hour. You may call and schedule an appointment with a BraunAbility dealer for repair without charge starting on June 13, 2019.

If you had this remedy performed on your BraunAbility vehicle prior to receiving this letter, you may be eligible to receive reimbursement for the cost of the remedy.
