This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Ford Motor Company has decided that a defect which relates to motor vehicle safety exists in your vehicle, with the VIN shown above.

We apologize for this situation and want to assure you that, with your assistance, we will correct this condition. Our commitment, together with your dealer, is to provide you with the highest level of service and support.

WARNING: DO NOT USE THE ENGINE BLOCK HEATER IN YOUR VEHICLE DUE TO THE RISK OF AN ENGINE COMPARTMENT FIRE AND/OR PROPERTY DAMAGE.

Why are you receiving this notice?

Our records indicate that you had previously been notified of Ford Safety Recall 18S45 affecting the engine block heater cord on your vehicle but have not yet scheduled a repair with a Ford dealer.

As explained below, we are instructing you not to use the engine block heater in your vehicle.

What is the issue?

If the block heater cord currently installed on your vehicle is plugged into a wall outlet, this may result in an inoperative engine block heater, tripping of household breakers or GFCI equipped outlets, and/or a resistive short. A resistive short increases the risk of overheated or melted wiring, and/or fire.

What is the risk?

If the engine block heater cord currently installed on your vehicle is plugged into a wall outlet, this may result in an inoperative engine block heater, tripping of household breakers or GFCI equipped outlets, and/or a resistive short. A resistive short increases the risk of overheated or melted wiring, and/or fire.

What will Ford and your dealer do?

Ford Motor Company has authorized your dealer to disable your existing engine block heater cord. The disabling of the cord will be done free of charge (parts and labor).

When replacement parts become available, Ford Motor Company will notify you via mail to schedule a service appointment with your dealer to replace your engine block heater cord assembly. This will also be done free of charge (parts and labor).

How long will it take?

The time needed to disable the engine block heater cord is less than one-half day. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.

What should you do?

MARNING: DO NOT USE THE ENGINE BLOCK HEATER IN YOUR VEHICLE DUE TO THE RISK OF AN ENGINE COMPARTMENT FIRE AND/OR PROPERTY DAMAGE.

Please call your dealer without delay and request a service date for Recall 18S45. Provide the dealer with your VIN, which is printed near your name at the beginning of this letter. The dealer will disable the block heater cord currently installed in your vehicle.

Ford has not issued instructions to stop driving your vehicle under this safety recall; however, Ford is instructing you not to use the engine block heater.

If you do not already have a servicing dealer, you can access www.Fordowner.com for dealer addresses, maps, and driving instructions.

Please note: Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
