On June 5, 2019 Forest Rivers Office of Corporate Compliance ("OCC") was notified of a potential concern with the way the 110V wiring and 12V generator prep wiring in the generator compartment had been installed.

On June 7, 2019 OCC opened an investigation into the concern. OCC visited the manufacturing plant to review the installation of the wiring and what the compartment looks like when it is generator prepped.

On June 14, 2019 OCC informed Forest Rivers Corporate Recall Committee of the investigation. The committee purposed the investigation continue.

On June 18, 2019 OCC identified six vehicles in the field in which the concern affects.

On June 21, 2019 the Corporate Recall Committee voted to recall the suspect vehicles.
