### Interior Rearview Mirror Glass Can Suddenly Detach - Safety Recall 3919G

Dear Mazda Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mazda Motor Corporation has decided that a defect which relates to motor vehicle safety exists in certain 2019 model year Mazda3 vehicles equipped with manual dimming mirrors and produced from September 25, 2018 through June 20, 2019. Note: Vehicles equipped with auto dimming mirrors are not affected by this recall.

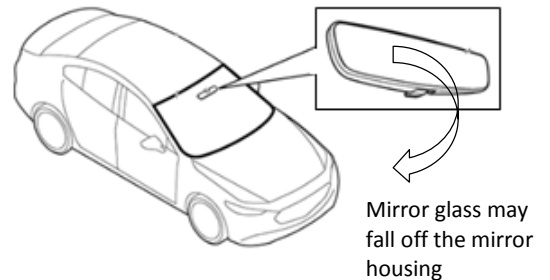
**If you received this notice, your vehicle is included in this Safety Recall.**

#### What is the problem?

On certain Mazda3 vehicles, the interior rearview mirror glass may suddenly detach from the mirror housing.

The mirror glass adhesive was not adequately bonded to the mirror housing during the manufacturing process of the interior rearview mirror unit. As a result, the interior rearview mirror glass on some units may not have full adhesion strength.

If the interior rearview mirror glass falls off the mirror housing, the driver may have reduced rearward visibility, which may increase the risk of a crash.



#### What will Mazda do?

#### Protect What Is Important To You

Your Mazda dealer will replace the interior rearview mirror unit with an improved part which has proper adhesion strength.

The repair will be performed at no cost to you.

#### How long will it take?

It will take approximately half an hour to complete the repair; however, your Mazda dealer may need your vehicle for a longer period of time.

Mazda will provide alternate transportation, if needed, when your vehicle is at an authorized Mazda dealership for a recall repair. Schedule an appointment with an authorized Mazda dealer so they can discuss and accommodate your needs.

**What should you do?**

Mazda is concerned about your safety, and we encourage you to contact any authorized Mazda dealer to schedule an appointment to have your Mazda vehicle repaired as soon as possible. You do not need to bring this notice to the dealer, but it may assist in the check-in process.

**Moved or no longer own this vehicle?**

Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
