### **Chronology:**

There were three warranty claims filed about bracket failure in a short period of time.

### **Description of Remedy:**

Description of Remedy Program: Based on the serial number, the potentially affected trailers will be

inspected. If the axle hanger bracket is one of the affected brackets, a gusset will be welded on both ends of the bracket to reinforce them. Dealers will be reimbursed for two hours of shop time per axle. Lippert will pay the shop time based on each dealer's standard rate. Customers who have experienced a bracket failure and have contacted LGS Industries or their dealer have had their trailer repaired under our warranty program. If a customer has resolved a failure and has not contacted LGS Industries, they would be reimbursed and their claim submitted to Lippert, as soon as they contact LGS Industries identifying a bracket failure

to their trailer.

How Remedy Component Differs Brackets with gussets on the ends will indicate a corrected component. If from Recalled Component: the bracket material is ¼" thick, the trailer was built with the correct

bracket.

Identify How/When Recall Condition Correction was made by revising the bracket from 3/16" material to 1/4" was Corrected in Production: material on 09/26/17 by LCI. However, due to concerns Look team members may have inadvertently installed a 3/16" bracket instead of 1/4" bracket the recall is extended through current production. LOOK is no longer ordering brackets of this type and has removed any opportunity for error from our production processes.
